All Ergotron® products will remain free of material and workmanship defects for the product category's time period term as measured from the date of purchase or date of delivery (if later than the date of purchase), subject to any exceptions, exclusions and limitations we outline below.

These warranties do not cover normal wear and tear, product abuse, product modifications, failure to follow product instructions, improper operations, damage caused by unauthorized service or repair, improper maintenance or failure to perform preventative maintenance, misuse, negligence, damages or defects caused by acts of God, damage from electrical power problems, damaged caused by use of parts or components not supplied by Ergotron, or damage caused by peripherals, accessories or software from external sources.

Ergotron is not responsible for damages, injury or loss arising from not following instructions related to the product's shipment, installation and intended use detailed in installation manuals, supplemental assembly and installation instruction sheets, technical bulletins and/or product literature. You will provide Ergotron immediate written notice of any property damage or personal injury resulting from the use of Ergotron products.

Monitor Mounts

- 15-year warranty on all TRACE™ products
- 10-year warranty on all HX products and all LX, MXV and MX monitor arms purchased on or after August 1, 2014
- 5-year warranty on NX products
- 3-year warranty on all Neo-Flex® products

Charging Systems: Zip and YES

- Limited Lifetime Warranty on the frames for as long as the original end user owns the product for defects in material and workmanship
- Five-year warranty on mechanical components such as casters, hinges, doors, handle, lock/padlock, dividers, shelves and associating fasteners
- Three-year warranty on electrical components on timer module, controller, electrical outlets, switches, power buttons or fans
- One-year warranty on cables such as power or ethernet cables

Mosaic Carts

- Lithium Iron Phosphate (LiFe) Batteries - Integrated
- 3-year warranty on LiFe battery capacity; Batteries are warranted to maintain at least 70% of the rated charge capacity for 3 years
- To claim the warranty, the cart's battery health must be assessed using one of the two options below:
 1. Through the cart's touch display and system settings
 2. Via RhythmConnect Fleet Control (if the customer has an active subscription)
- 5-year warranty against manufacturer's defects on Integrated Mosaic LiFe batteries (excludes replacement batteries);
- First 3 years: Covered at 100%

StyleView Carts

- Lithium Iron Phosphate (LiFe) Batteries - Integrated

- 3-year warranty on StyleView LiFe battery capacity; Batteries are warranted to maintain at least 70% of the rated charge capacity for 3 years.
- To claim the warranty, use the StyleLink client application to confirm battery health.
- 5-year warranty against manufacturer's defects on integrated StyleView LiFe batteries (excludes replacement batteries);
- First 3 years: Covered at 100%
- Sealed Lead-Acid (SLA) Batteries – Integrated
- 90-day capacity warranty on integrated StyleView SLA batteries (excludes StyleView SLA replacement batteries)
- SLA batteries carry a 6-month warranty against manufacturer's defects, or as mandated by local law
- Both SLA batteries must be replaced at the same time following the recommendation in the Ergotron user manual or the battery warranty is void
- Warranties on StyleView SLA batteries left unused for more than three consecutive months are void
- 3-year warranty on electric lift motor and switch
- 1-year warranty on electronic components such as auto lock drawers, auto lock systems, keyboard lights, user interface, battery harness, cables from user interface to power module, touch screen controller, lights, drawer control boards, power distribution unit and base control unit
- Excludes all consumables such as AA batteries

- Excludes all consumables such as AA batteries
- 2-year warranty on power modules and coiled power cords by Ergotron

What Steps to Take for Product Repairs

Warranty Repair

If any Ergotron equipment becomes defective in material or workmanship during the warranty period as determined by Ergotron at its sole discretion, Ergotron may elect to replace or repair the unit or refund the purchase price of the product in the event Ergotron is unable to provide a replacement and repair is not commercially practicable or cannot be timely made. You must receive pre-approval by Ergotron for any costs related to the repair or replacement of warranty products.

You must contact Ergotron for a return material authorization (RMA) number by reaching out to Ergotron Customer Care online or by telephone within your specific region. Contact information is available on the [Ergotron website](#). Repairs or product replacement under warranty does not renew or extend the warranty period.

Non-Warranty Repair

You may return a product for repair that is not covered by warranty if you have received a preapproved RMA number from Ergotron Customer Care. Labor costs and freight charges associated with non-warranty repair will be the sole responsibility of the customer, reseller or installer/integrator.

A standard repair fee, specific to the product, is charged for any product that is repaired outside of the warranty period. Repairs on products out of warranty also carry a 90-day warranty, effective the day that you receive the item after repair.

For products that are not covered under warranty, Ergotron offers the following options:

1. You may upgrade to a newer, equivalent product at a similar suggested selling price (SSP)
2. Ergotron will return the product to you at your cost
3. You can request in writing that Ergotron appropriately dispose of the product for you (fees may apply based on local laws)

If Ergotron notifies you that a returned product is not defective after testing, then the product will be returned to you. You would be responsible for the freight charges associated with the return.
